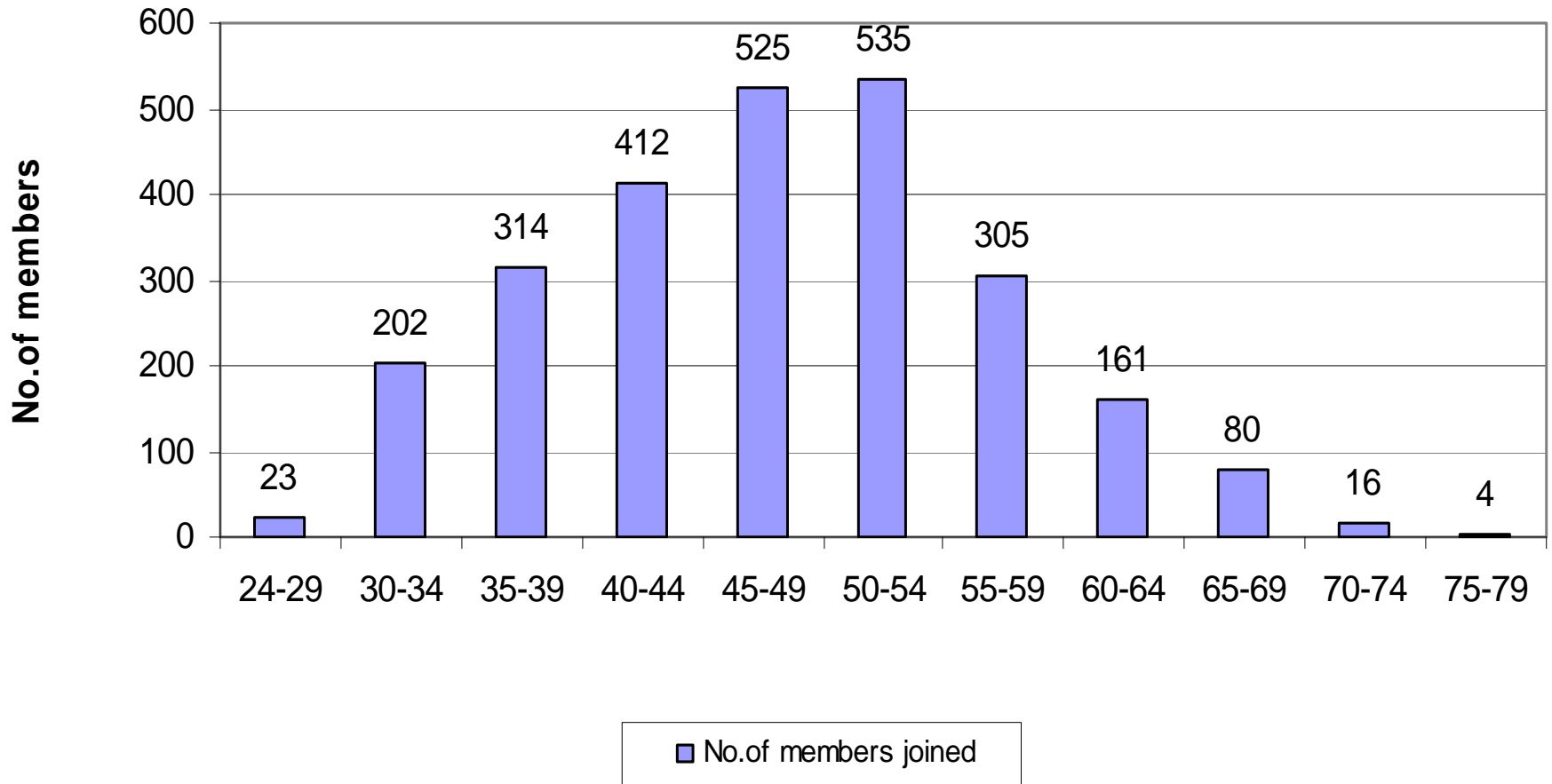

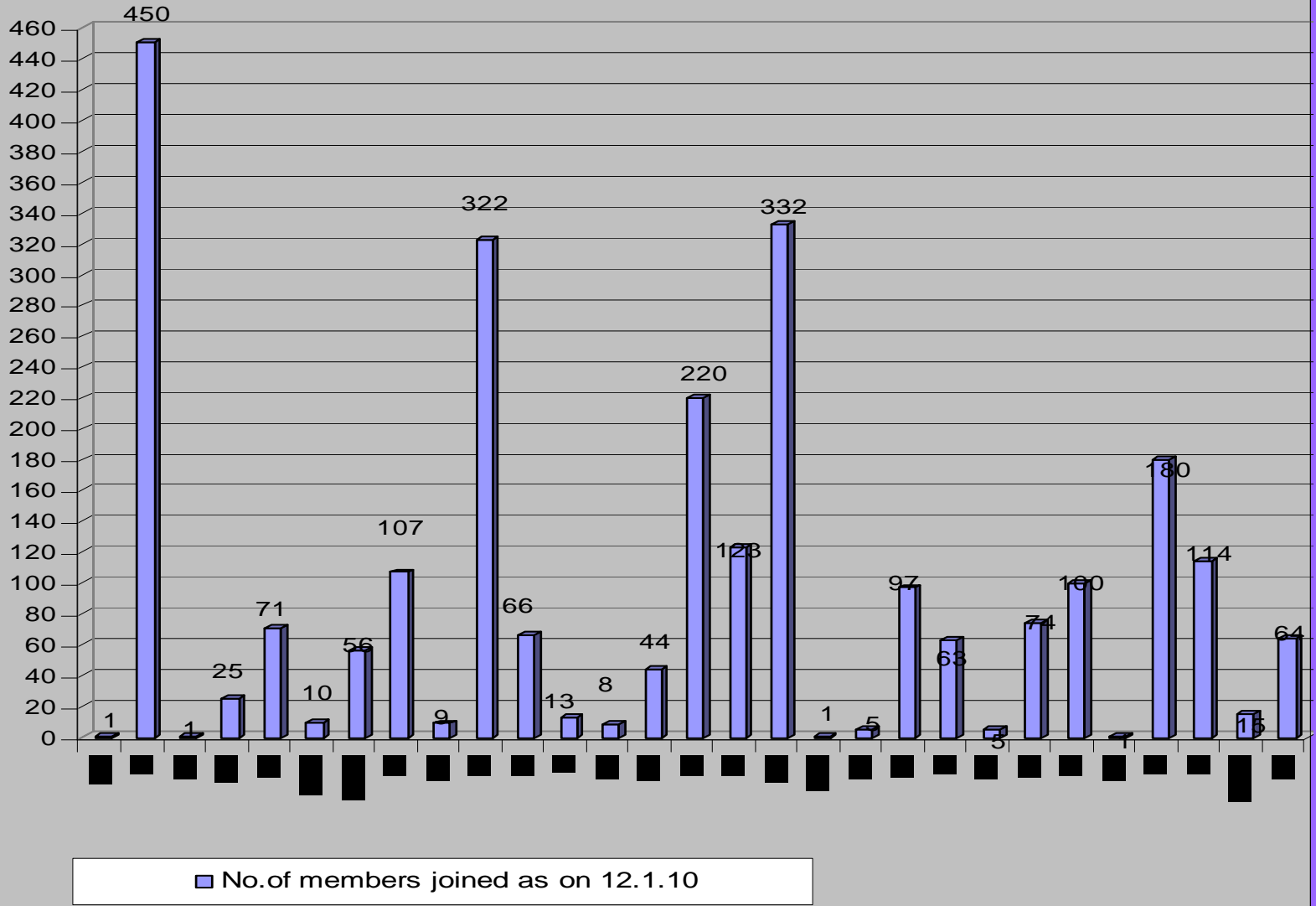

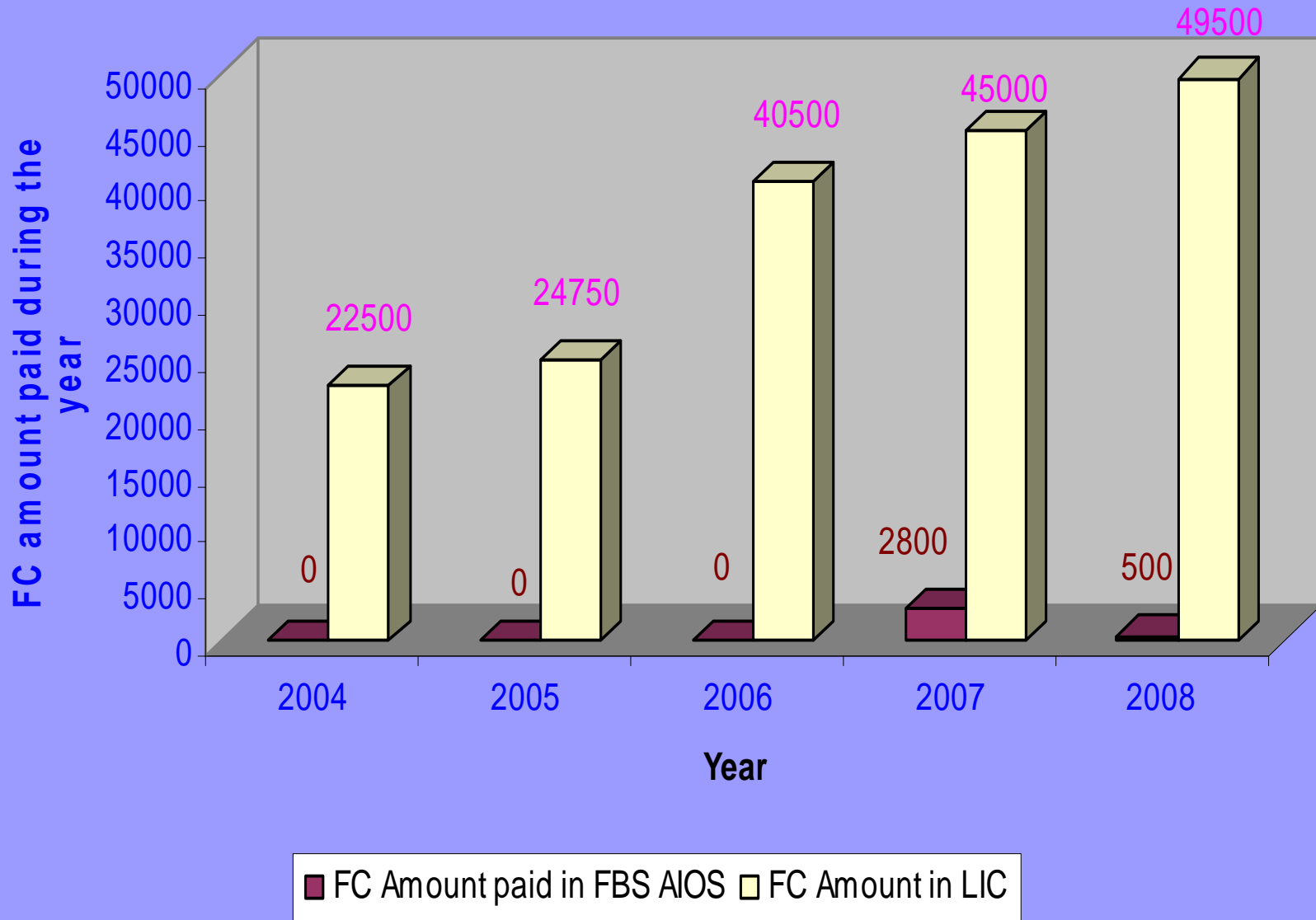
Age wise No.of members joined



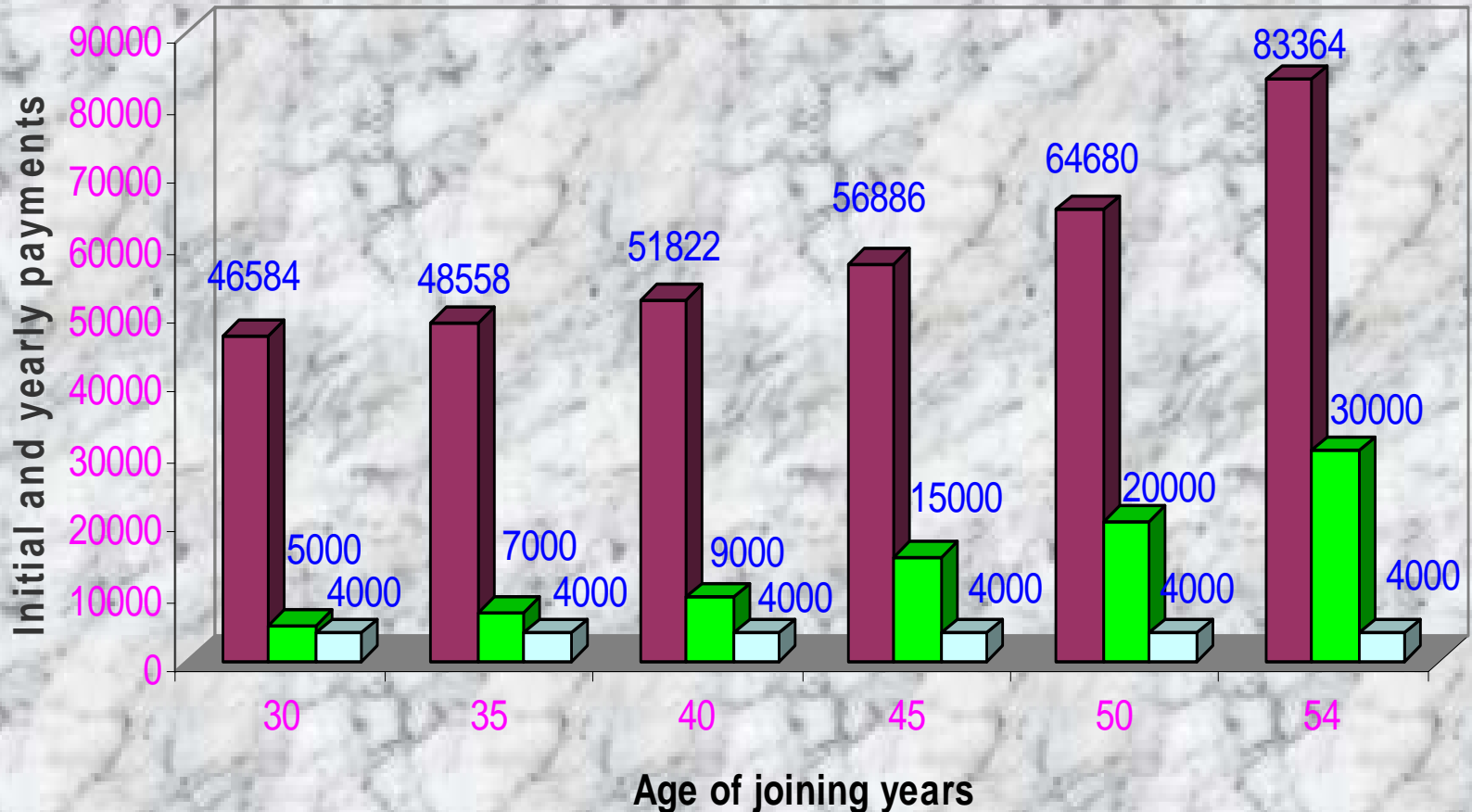
State wise No.of members joined in FBS as on 12.1.10
